### Guidelines for submission of abstracts

The Scientific Committee encourages all participants to contribute to the scientific program by submitting their papers for oral or video presentations. Abstracts must be submitted in English.

#### Official Abstract Submission Form:

- Abstracts will be produced as computer scans from the material submitted. To ensure optimal scanning, they must be printed in black ink with a good quality printer. The font size should be at least **10-point** and **Times New Roman** should be used where practicable.
- Titles should be printed in **bold**.
- Authors' names should be in CAPITALS. Place an asterisk (\*) next to the name of the presenting author. Please omit titles and degrees.
- Name, institution and city should be typed, but full addresses are not necessary.
- Single space all typing. Do not leave blank lines. Use standard abbreviations. Place a special or unusual abbreviation in parenthesis after the full word the first time it appears. Use generic names of drugs. Express numbers as numerals rather than words.
- The title should not contain more than 70 characters, including spaces. The text should be kept completely within the abstract form provided and not exceed 350 words. Tables may be included if they fit the abstract box.
- The abstracts should state clearly the purpose, methods, results and conclusions of the study. Phrases such as «the results will be presented and discussed» will not be accepted.
- Do not make any corrections on the official abstract form. Corrections should not be necessary, as you will have practiced beforehand on a photocopy of the form.
- The abstracts and the full texts in case of award papers should be submitted together with 3 copies.
- Authors presenting abstracts **must be registered** participants and members of IEA or IES.
- Incomplete submissions and submissions not following guidelines will NOT be accepted.
- In case of video presentation only limited amounts remain unusual or atypical presentations are encouraged the decision of the same will depend on the time available and also on the message that can be gained from the same.

*Objectives*: To achieve the best presentation of your scientific contribution to the ECON 2008.

#### Methods:

Read the guidelines to authors' carefully. The abstract must be written in English and typed on the original Abstract Form using at least a 10 pitch font. Additional Abstract Forms may be obtained from the Conference Bureau or at the Conference web site. Although the abstracts will be edited, authors are encouraged to submit error-free abstracts. Use a short and concise title. List authors and place an asterisk (\*) next to the presenting author. After the last author's name, list the institution, city and state for each author; omit degrees, titles and full address. Use standard abbreviations. Place a special or unusual abbreviation in parenthesis after the full word the first time it appears. It is strongly recommended to structure the text as shown in the present example.

*Results*: The abstract gives the background, methods, results and conclusions. It fits well within the frame provided and can be read easily.

*Conclusions*: By complying with the guidelines the authors will achieve the best presentation of their abstracts.
