- ii) An attested copy of certificate from the Board showing his/her date of birth.
- iii) An attested copy of mark-sheet of the qualifying examination i.e. 12th class under 10+2 Scheme/Intermediate Science or an equivalent examination in proof of having secured 50% or more marks (45% in case of SC/ST candidates) in aggregate in the subjects of English, Physics, Chemistry and Biology OR Mathematics.
- iv) In case of SC/ST/OBC candidates, an attested copy of SC/ST/OBC certificate in the prescribed proforma issued by the competent authority, as prescribed in the prospectus.
