He also welcomed and introduced Dr. Vishwas Mehta, new Joint Secretary in the Ministry of Health and Family Welfare. Thereafter, the agenda items were taken up for discussion.

CONFIRMATION OF THE MINUTES OF 200<sup>TH</sup> MEETING OF THE STANDING FINANCE COMMITTEE OF AIIMS HELD ON 16.03.2012 IN THE MINISTRY OF HEALTH & FAMILY WELFARE, NIRMAN BHAWAN, NEW DELHI.

It was informed that the minutes of 200<sup>th</sup> meeting of the SFC were circulated to all members on 7<sup>th</sup> April, 2012. No observations had been received. The minutes were accordingly confirmed.

# ITEM NO.SFC-201/2

ACTION TAKEN ON THE MINUTES OF 200<sup>TH</sup> MEETING OF THE STANDING FINANCE COMMITTEE OF AIIMS HELD ON 16.03.2012 IN THE MINISTRY OF HEALTH & FAMILY WELFARE, NIRMAN BHAWAN, NEW DELHI.

The SFC noted that a large number of faculty posts particularly at the level of Assistant Professor were yet to be advertised for recruitment.

Secretary(Health and Family Welfare) pointed out that the Hon'ble Minister had also written a note to Director, AIIMS on that issue for advertising all the vacant posts of Assistant Professors within May, 2012. Director, AIIMS informed the SFC that the Institute was in the process of filling up the earlier advertised vacant posts. He was of the view that the present vacant posts should be advertised after some time as otherwise if all the posts particularly the posts of Asstt. Professors were to be filled up at once, then after a period of three years there will be no person available at the level of Assistant Professors since all the Assistant Professor would then be promoted to the

level of Assoc. Professor under APS. In order to avoid such vaccum, such vacancies should be filled up in phased manner. Dr. Vishwas Mehta, Joint Secretary, Ministry of Health and Family Welfare informed that the Parliamentary Committee had also raised the question about the non-filling of vacant posts at AIIMS. AS&FA was of the view that if the vacancies were not being filled, then there was no use of creation of new posts. He expressed the apprehension that if the vacant posts were not filled up, then such posts would be liable to be abolished as per the instructions of the Ministry of Finance.

It was, therefore, decided that the Institute would first advertise the posts of Assistant Professor and then the vacant posts of Professors, once the rosters for them (Assistant Professors and Professors) are made properly and ready.

The SFC noted that HLL had agreed to open the generic medicines outlet at AIIMS. It agreed that supervision of such outlets could not be with the DD(A). Hospital Administration had to provide the requisite oversight and supervision. It was, therefore, agreed that Director would constitute a Monitoring Committee whose members would change after every six months. The Committee would oversee all issues of pricing, quality control and dispensing of drugs.

The SFC also directed that the construction of New OPD at CRHSP Ballabhgarh should be ready for tendering within three months.

The SFC was informed that the Thorat Committee recommendations had been circulated to all SFC members. A copy of the report of Dr. S.P. Aggarwal had also been received and would be circulated to all members of the Institute Body.

As regards running of the English language programme for the students, it was informed that the Director had already written to the Jamia Millia Islamia. This would be followed up. The Committee was further informed that CREST would implement a 10 day self enhancement programme for the new batch of MBBS students from 16<sup>th</sup> July, 2012.

## ITEM NO.SFC-201/3

PROPOSAL FOR ANNUAL PLAN INCURRING THE EXPENDITURE UNDER "PLAN" AND "NON-PLAN" HEADS FOR THE FINANCIAL YEAR 2012-13.

Shri Sandeep Lall, Sr. FA briefed the SFC.

The SFC noted the additional requirement of funds projected under Plan and Non Plan. It was agreed:-

- (i) Secretary, Ministry of Health and Family Welfare would write to Secretary (Expenditure) for allocation of additional funds under Non Plan to the Institute.
- (ii) The Institute should finalize its proposal for charging consumables etc. required for teaching activities to Plan instead of Non plan so as to shift the load from Non Plan.
- (iii) The additional requirements would be taken care of at RE stage.

PROPOSAL FOR REVISION OF PACKAGE CHARGES FOR VARIOUS CARDIAC PROCEDURES/SURGERIES AT C.T.C., AIIMS, NEW DELHI.

Dr. Balram Airan, Chief C.T. Centre briefed the SFC about the proposal. The SFC was informed that the decision taken by the SFC in its 197<sup>th</sup> meeting held on 11<sup>th</sup> November, 2010, which was ratified by the Governing Body in its 144<sup>th</sup> meeting and reiterated by the Governing Body in its 146<sup>th</sup> meeting, was yet to be implemented. Main reason was the inability of AIIMS Hospital as to prepare the components of various packages. Concern was also expressed over the fact CGHS beneficiaries especially pensioners were not getting cashless facilities in the Institute. The SFC decided that Ministry of Health and Family Welfare would be requested to park a corpus with AIIMS for providing cashless facilities to CGHS beneficiaries. The corpus could be periodically replenished by CGHS. It was further decided that till such time the packages were developed, patient of private wards would be billed on actual and would not be asked to procure consumables, drugs etc. on their own.

Regarding the proposal submitted by the Chief CTC, the SFC reiterated the decision that the charges for procedures in General Wards need to be offset by revenue generated from the private wards to make the treatment in general wards free to the extent possible. There was considerable discussion on this matter. Chief, CTC indicated that even now they are providing free treatment to all BPL families. If treatment in general wards was to be totally free then based on last year's figures, an amount of Rs. 40 crores would be required. Moreover, once treatment was made free, the number of patients would increase exceptionally and consequently waiting time and funds requirement would also increase proportionately. Taking into consideration all factors and the decisions of the Governing Body The SFC decided as under:-

- Rates for new procedures proposed to be introduced for the first time were approved.
- Marginal increase in rates for procedures proposed was disapproved.
- Reduction in rates proposed was approved.
- Procedures for which no change has been proposed were also approved.

Approved package rates for CTVS surgeries/procedures, Angiography procedures and Cardiac Radiology procedures for General Ward in CTVS, AIIMS are as under:-

# ITEM NO.SFC-201/5

STATUS OF PROJECTS UNDER EFC APPROVED FOR IMPLEMENTATION OF RECOMMENDATIONS OF OVER SIGHT COMMITTEE FOR AUGMENTATION OF SEATS.

The DD(A) and SE briefed the SFC about the status of various projects under implementation at AIIMS under the Moily Committee award –

- (i) The SFC noted that the work on the Augmentation Block II, Convergence Centre and Hostel Block at Masjid Moth had already started.
- (ii) The SFC was informed that NDMC was not accepting the building plans for the Mother and Child Centre and the Surgical Centre as the change in land use from residential to institutional had not been approved by the Delhi Development Authority. The SFC was furthered informed that the Ministry of Urban Development had now approved the change of land use. Therefore, the building plans for these centres would be resubmitted to the NDMC.
- (iii) The SFC noted that the Master Plan for Ayurvigyan Nagar had been cleared by the MCD. Environmental clearance was being obtained. Simultaneously building plans for the residential units would be finalized for submission to MCD.
- (iv) The SFC advised that for the surgical block, extension in bid validity should be obtained so that the building plans could be resubmitted to the NDMC and work could be awarded after clearance by Delhi Fire Service and DUAC.

PROPOSAL FOR AWARD OF CONTRACT FOR DEPLOYMENT OF SECURITY AGENCIES FOR WATCH AND WARD SERVICES AT AIIMS – AFTER OPEN TENDERING PROCESS-REG.

Shri A.K. Kamra, Chief Procurement Officer briefed the SFC about the proposal. The SFC was informed that wages payable to the security agencies were based on the prevalent rates notified by the Chief Labour Commissioner (Central), Ministry of Labour and Employment. The only variable was the service fee quoted by the bidder. SFC was also informed that earlier the contract of providing man-power for watch and ward services was being given to one agency. Now this has been split into two units with the condition that the bidder who emerged L.I bidder under Unit A, his bid for Unit B would not be considered. Accordingly, the SFC accorded approval for award of contract to the lowest evaluated bidder as under:-

## ITEM NO.SFC-201/11

TO CONSIDER THE REQUEST OF DR. BALRAM BHARGAVA, PROFESSOR OF CARDIOLOGY AT THE AIIMS, NEW DELHI TO ENTER INTO AN AGREEMENT WITH STANFORD UNIVESITY, USA.

The Director informed that the payment of USD 400 per month was to be made in the form of Honorarium on monthly basis. This was supposed to be made from the date the MoU had been signed. This type of assignment was against the present guidelines of AIIMS. He expressed his apprehension that this type of practice would also be claimed by other faculty members including for working in clinical trials. He further informed that a committee had been constituted under Dr. S.K. Panda, Prof. & Head of the Deptt. of Pathology to look into such issues and once the report is submitted, the same would be placed before the SFC.

The Health Secretary expressed that the faculty members should be encouraged to do more and more innovative research and also to collaborate with other organization of the attrition rate would be very high in the Institute.

The Director assured that once Dr. S.K. Panda submits his report, a general policy as per recommendations of the Valiathan Committee would be placed before the SFC for consideration.

With the aforesaid deliberations, the agenda item was withdrawn.

#### **ITEM NO.SFC-201/12**

REGISTRATION OF ACRONYM AIIMS AS A REGISTERED TRADE MARK OF THE ALL INDIA INSTITUTE OF MEDICAL SCIENCES, NEW DELHI.

Director briefed the SFC about the proposal.

It was decided that this matter should be placed before the Governing Body for a final decision, in view of the implications for other AIIMS like Institutions.

### ITEM NO.SFC-201/18

CONSTRUCTION OF OUTREACH "O.P.D." FOR "AIIMS" AT BADSHA, JHAJJAR, HARYANA

The DD(A) and SE, AIIMS briefed the SFC about the proposal.

The SFC noted that the construction of the Outreach OPD at Badhsa had been started and was to be completed in a time bound manner. It also noted that the foundation stone for the Outreach OPD was being laid on 30<sup>th</sup> May, 2012.

Taking into account the requirement of AERB for X-Ray equipment and the recommendations of the HSCC, the SFC approved the proposal for building the construction with bricks instead of prefabricated synthetic panels.

#### **ITEM NO.SFC-201/19**

CONSTRUCTION	OF	"NEW	PAID	WARD"	IN	AIIMS	CAMPUS,

DD(A) and SE briefed the SFC about the proposal.

The SFC noted that the renovation of the existing old private ward block had been approved by the SFC in its 197<sup>th</sup> meeting held in November, 2010. Thereafter in the 198<sup>th</sup> meeting, it had been reiterated to the SFC that as per the study conducted by the IIT Roorkee to assess the seismic stability of the building, extensive retrofitting had been recommended that would entail stripping of the entire building to reinforce the steel used in its construction. The time required for such retrofitting was 12 months. As against this, if the building was demolished and reconstructed an 8 storey block could be constructed that would double the current capacity and also create facilities for basement parking for more than 300 cars.

The SFC further noted that M/s. HSCC, the Project Consultant, had undertaken pre-qualification of construction agencies in which 16 firms had applied. After evaluation only 4 firms were found eligible. No time escalation was allowed in the bid and there was a provision for liquidated damages for delay which could be maximum 5% of the tendered amount. Bids have, however, been submitted only by M/s. L&T Construction and M/s. Unity Infrastructure Projects Limited. The SFC noted that after negotiations, the net total amount quoted by L&T Construction, which is the L.1 bidder

comes to Rs.89,33,44,001.00. HSCC had compared this amount with the justified market rate amount (after factoring in escalation) of Rs.81,41,24,328.50. L.1 amount was thus 9.73% higher than the justified market rate, which could be considered as per the CPWD manual in special circumstances.

#### The SFC further noted that

- The demolition and reconstruction had to be done in a fully functional hospital.
- The construction period had been fixed at 15 months and there was no provision for time and amount escalation.
- The hospital was located in NDMC area, where movement of trucks was extremely regulated and no re-movement of material would be possible during the day time.
- Construction work would need to be extremely carefully so as not to disturb the patients in the adjoining blocks.
- No storage space would be available nearby, in view of the fact that the old private ward was surrounded by functional blocks and centres.
- Very limited working space would be available given the fact that the underground water storage tank, causality block and the general ward block were adjacent to the old private ward and would be functional. Therefore, only a construction agency of repute and considerable experience would be able to execute such a complex work.

The SFC was, therefore, of the view that given these circumstances and the fact that the demolition and reconstruction of the old private ward block at AIIMS be awarded to L&T Construction at the negotiated net amount of Rs.89,33,44,001.00. It further authorized the SE to do the necessary documents in this behalf. It further advised that the demolition work should carefully undertaken so that no threat is caused to the adjoining structures.
