Shri V.S.Oberoi, Secretary, Department of Higher Education and Prof. Dinesh Singh, Vice Chancellor, Delhi University could not attend the meeting and were given leave of absence by the Chairman. The quorum for the meeting was fulfilled. At the outset, Director, AIIMS & Member Secretary of the SFC welcomed the Chairman & Secretary (Health), the eminent Members and the Special Invitees to the 209th meeting of the Standing Finance Committee. Chairman requested Member Secretary to introduce the agenda and initiated discussions on the agenda items.

The decisions taken on the agenda items are the following:

ITEM NO. SFC-209/1

CONFIRMATION OF THE MINUTES OF 208TH EXTRA ORDINARY MEETING OF THE STANDING FINANCE COMMITTEE OF AIMS HELD ON 20.07.2015 IN MINISTRY OF HEALTH AND FAMILY WELFARE, NIRMAN BHAWAN, NEW DELHI.

The Minutes of 208th Extra Ordinary meeting of the SFC of AIIMS, New Delhi, circulated vide F.No.4-3/2015-Genl. dated 01.08.2015 were considered and confirmed.

ITEM NO. SFC-209/2

TO CONSIDER THE PROPOSAL FOR MOU WITH NBCC FOR RE-DEVELOPMENT OF WESTERN CAMPUS AND AYURVIGYAN NAGAR.

A presentation on the re-development of AIIMS Western Campus and Ayurvigyan Nagar was made by NBCC. The NBCC indicated that u/r 126 of GFR any Ministry/ Department can assign the capital work of any value to NBCC on nomination basis. The NBCC indicated that 3000 flats of different types would be constructed in 2.5 years time, with a financial implication of Rs. 5828 crores. The revenue generation for commercial viability for the construction would be met by selling 10 percent of area. The NBCC indicated that they would be charging 10 percent of the final project cost as PMC fees and 1 percent for marketing expenses on total fund realisation from sale/ lease of built up areas.

The SFC recommended in-principle the proposal for re-development of the western campus with the condition that, the MOU with NBCC will be signed only after the project approval of competent authority which is the union cabinet in the present case.

TO CONSIDER THE PROPOSAL FOR TRAUMA EXPANSION PLAN COMPRISING OF TRAUMA CENTRE, CENTRE FOR ENT, CENTRE FOR DIABETOLOGY AND CENTRE FOR DIGESTIVE DISEASE.

The SFC recommends in-principle the proposal for phased development given the requirements for AIIMS campus expansion. Civil works would be carried out in a manner which allows future expansion. The SFC was of the unanimous view that the Center for Digestive Diseases, Center for ENT, Center for Diabetology, the Trauma Expansion & Rehabilitation Block, The Transplant Block and the General Facility Cluster Block along with other centers proposed by AIIMS were a felt need and recommended to start working on the projects towards establishment of Expansion of TRAUMA CENTRE, CENTRE FOR ENT, CENTRE FOR DIABETOLOGY AND CENTRE FOR DIGESTIVE DISEASE.

ITEM NO. SFC-209/5

STATUS OF RCE PROPOSAL OF CONSTRUCTION WORKS BEING TAKEN-UP UNDER OVERSIGHT COMMITTEE RECOMMENDATIONS.

The SFC noted the status of implementation of works under the Oversight Committee Recommendations. The SFC also noted that a standing committee has been constituted under the chairmanship of Additional Secretary (H) to examine the response of AIIMS on the comments of the Department of Expenditure. AIIMS informed that a meeting date was sought for convening the meeting of the Standing Committee. There were suggestions put forward by Shri Ali Rizvi and Smt. Vijaya Srivastava, AS FA to separate the civil works and equipment and manpower costs for various Centres (Surgical Block and Mother & Child Centre) and take it for approval. Shri V Srinivas, DD (A), AIIMS and Shri Ali Rizvi to work out the modalities.

ITEM NO. SFC-209/6

CURRENT STATUS OF EXECUTION OF ENGINEERING PROJECTS INCLUDING MOTHER CHILD BLOCK, SURGICAL BLOCK, OPD BLOCK, NATIONAL CANCER INSTITUTE AND HOSTEL BLOCK.

The status of execution of engineering projects was reviewed and found satisfactory.
