- 1) Cadre of Medical Record (Detail of the proposal annexed as Annexure-I):-
  - The issue of method of recruitment in respect of the post of Medical Record Technician has been discussed and the committee is of the opinion that method of recruitment is required to 50% by Direct and 50% by Promotion from HA & SA working in Medical Record Section.
  - Further, the post of JMRO & MRO to be merged at the level of MRO in the pay scale of Level-7 in addition with 6 months certificate course may be made mandatory for promotion.

### 1) Cadre of Finance & Accounts (Detail of the proposal annexed as Annexure-V):-

- The committee is of the opinion that the number of posts are required to be increased keeping in view of expansion of various activities at the AIIMS, New Delhi and increase of work load day by day.
- The committee consider for merger of entry level post i.e Junior Accounts Officer to Assistant Accounts Officer.
- Suggested upgradation in level of pay may be looked into by taking into consideration of the Administrative Cadre at AIIMS.
- The committee is of the opinion that graduation may be added in the entry level post.
- The Sr. Financial Advisor agreed to look into all aspects and submit a new / revised Cadre Review proposal for Accounts Cadre.

## 2) Cadre of Pharmacist (Detail of the proposal annexed as Annexure-VI):-

- The representative agreed with the recommendation of the Co-ordination committee.
- The committee noted that the pay scale proposed by the Co-ordination committee for the post of Chief Pharmacist is Level-9. The committee suggested upgradation in pay scale for this post to Level-10.
- Further, to consider increase / decrease of number of posts in cadre structure, there is need to analysis the same by the Cadre Controlling Authority.

### 3) Post of Cytoscreener (Isolated post) (Detail of the proposal annexed as Annexure-VII):-

- The committee considered the proposal submitted by the stakeholder(s) and opined to continue with the present status of the post.
- Further, the committee was of the opinion that the post of Cytoscreener is an isolated post at this Institute and the same may be considered for merger of the post with Scientist-I, seprately.
