


With reference to your application for the post of Deputy Chief Security Officer on deputation basis at this Institute and recommendations of the Selection Committee on the basis of interview held on 20-11-2024, you have been shortlisted for appointment to the post of Deputy Chief Security Officer on deputation basis in Level-11 in the Pay Matrix plus other usual allowances as are admissible to the Central Government servants of this status on foreign service terms & conditions contained in the DOPT's O.M. No.6/8/2009-Estt.(Pay-II) dated 17-06-2010 as amended from time to time.

2. Accordingly, the aforesaid post is being offered to you, on the terms and condition as are made applicable at the institute from time to time, some of which are indicated here as under:-

- (i) The appointment is on full time basis and private practice of any kind is prohibited.
- (ii) The period of deputation shall not ordinarily exceed 03 years or till further order, whichever is earlier.
- (iii) The appointee is required to conform to the rules, regulation, discipline and code of conduct prevailing in this Institute and those imposed by the Institute on its employees from time to time.
- (iv) If any of the declaration made or information furnished is proved to be false or found to be wilfully suppressed, the appointment on deputation basis is liable to be cancelled/ terminated besides any other action that the Institute may deem necessary.
- (v) The deputation to the Institute will be regulated as per terms and condition detailed in Department of Personnel & Training's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 as amended from time to time.
- (vi) The Institute reserve the right to transfer or utilise the services at the centres of the Institute located at Ballabhgarh (Haryana) / National Drugs Dependency Treatment Centre (Ghaziabad) / Badsa/ NCI, Jhajjar and at any other centre to be opened by the Institute in future.

If the offer is acceptable to you on the aforesaid conditions, you may please communicate your acceptance to the undersigned immediately and also report yourself for duty as early as possible, but not later than **28-12-2024**. In case, you do not send your acceptance immediately or do not join the post by the stipulated date, your candidature for the post may be treated as cancelled / withdrawn.
