





Respected Sir,

Honourable Minister of Commerce and Industry has directed GeM to conduct a review every 2 months of the departments that are not buying from GeM and to inform the Secretary (Expenditure) about the reasons for their inability in actively transacting through GeM.

2. For enabling a comprehensive review of this nature on a regular basis, GeM would be needing information about the scale of overall procurement, excluding works, of all the Ministries/Departments, including their CPSEs and autonomous organizations. A comparison of the procurement potential of each Ministry with the procurement happening through GeM will help us in identifying the extent of procurement being done on GeM by the various Ministries/Departments.


3. It is requested kindly to arrange to provide the figures of total procurement made through all sources for the preceding 3 years upto FY 2020-21 for:

It is also requested to kindly indicate any further measures or requirement of additional functionalities for accelerating procurement through GeM.






