**OFFICE MEMORANDUM**

**Sub: Installation of EV charging stations under Solar Hangers on Shiva Road**

Ref: OM No. F. No. 40-30/2025-Estt.I dated 20.05.2025, vide which it had been advised that additional high power EV charging stations should be installed under the solar hangers on Shiva Road to ensure prompt charging of the electric vehicle fleet.

In this regard, the undersigned has taken comprehensive rounds of the AIIMS Campus and basement parkings on various occasions and noted with concern that several electric vehicles and electric buses deployed for patient and staff convenience are currently underutilized due to the continued lack of adequate charging facilities. This defeats the very purpose of inducting environment-friendly electric vehicles and represents suboptimal utilization of valuable institutional assets.


It has been consistently emphasized that AIIMS New Delhi has put in lot of efforts in deploying electric vehicles including parikrama seva carts, electric buses, and electric staff cars to enhance patient care services while maintaining carbon neutrality. However, the intended benefits of this green initiative cannot be realized unless adequate charging infrastructure is established.

Given that optimal utilization of any institutional asset is paramount and constitutes a fundamental principle of efficient resource management, it is reiterated that:

1. The installation of additional high power EV charging stations under the solar hangers on Shiva Road must be completed and commissioned on priority basis.
2. Any subsidies or benefits for installation of EV charging stations offered by the Government of India or Government of NCT of Delhi shall be explored and availed to support the installation of the said charging infrastructure.
3. The entire installation work and commissioning of all 30 charging stations must be completed by 31st March 2026 without any further delay.

4. A fortnightly progress report on the status of installation shall be submitted to the Office of Director commencing from 15th February 2026.


**Sub: Installation of eVehicle Charging facility of Shiva Road reg.**

Ref. OM No. 40-30/2022-Estt.I dt. 5.10.2023, it has been emphasised that as AIIMS New Delhi is inducting a large number of electric vehicles (including parikrama seva carts, electric buses, electric staff cars, etc.) for the convenience of patients, their attendants and AIIMS staff while remaining carbon neutral, there is a requirement to install additional EV charging points to ensure optimal utilization of the electric fleet.

The undersigned has visited the Central Transport & Parikrama Seva garage and has noted that the existing charging infrastructure therein is still inadequate to ensure simultaneous and optimal charging of the deployed EVs.

Accordingly, to augment the EV charging infrastructure at AIIMS New Delhi, it is once again reiterated that 30 nos. of additional high power EV charging stations shall be commissioned under the solar hangers on Shiva Road before 31<sup>st</sup> July 2024 after following due procedure. Any subsidy / benefits for installation of EV charging stations offered by Govt. of India / Govt of NCT of Delhi be also explored to support the installation of the said charging infrastructure.

**Sub: Installation of EV charging stations under Solar Hangers on Shiva Road**

AIIMS New Delhi has in the past one year inducted over 30 electric vehicles (EVs) for the convenience of patients, their attendants and AIIMS staff while remaining carbon neutral. Also, efforts are on to induct additional EVs for patient & staff transit within the campus in the coming days.

To ensure optimal utilization of the EVs, it is essential to install adequate number of charging stations for the EVs in AIIMS New Delhi. The undersigned has visited the Central Transport and has noted that the existing charging infrastructure therein is inadequate to ensure simultaneous and optimal charging of even the existing EVs.

Accordingly, to augment the EV charging infrastructure at AIIMS New Delhi, it has been decided to install 30 nos. of additional EV charging stations under the solar hangers on Shiva Road before 30<sup>th</sup> November 2023 after following due procedure. Any subsidy / benefits for installation of EV charging stations offered by Govt. of India / Govt of NCT of Delhi be also explored before installation of the said charging infrastructure.
