The undersigned is directed to say that the timeline for distribution of blank e-APAR forms and completion of self-appraisal for Group 'A', 'B', & 'C' officers including Faculty Members of AIIMS, New Delhi has been re-scheduled on account of lockdown to stop of spread of Novel Corona virus (COVID-19) in pursuance of DoPT O.M. No.21011/02/2015-Estt(A-II)-Part II dated 30th March 2020. Accordingly, the time schedule for recording and completion of e-APAR for the assessment year 2019-2020 for Group 'A', 'B', & 'C' officers including Faculty Members of AIIMS are as under:



1.	Distribution of blank APAR forms	31 st May, 2020
2.	Submission of self-appraisal to reporting officer	30 th June, 2020
3.	Forwarding of report by reporting officer to reviewing officer.	31 st July, 2020
4.	Forwarding of report by reviewing officer to APAR Cell/ Accepting Authority (wherever provided)	31 st August, 2020
5.	Appraisal by accepting authority, wherever provided or applicable	30 th September, 2020
6.	(i) Disclosure of APAR to the officer reported upon where there is no accepting authority. (ii) Disclosure of APAR to the officer reported upon where there is accepting authority	10 th September, 2020 10 th October, 2020
7.	Receipt of representation, if any, on APAR	15 days from the date of disclosure
8.	Forwarding of representation to the competent authority (a) Where there is no accepting authority for APAR (b) Where there is accepting authority for APAR	30 th September, 2020 31 st October, 2020
9.	Disposal of representation by the competent authority	Within one month of date of receipt of representation by the competent authority
10.	Communication of the decision of the competent authority on the representation by the APAR Cell	Within 15 days of finalization of decision by competent authority
11.	End of entire APAR process, after which the APAR will be finally taken on record	31 st December, 2020

It has further been decided that for the e-APAR assessment year 2019-20, the extended timelines specified as above shall also apply to the reporting/reviewing officer and accepting authorities, who have demitted office or retired from service on or after 29.02.2020. They shall be allowed to record their remarks till the respective extended cut-off dates.
