OFFICE ORDER

Budget for the implementation of the scheme of Financial Incentive to Good Samaritans/By Standers for transporting Road Traffic Accident Victims to Hospital for treatment and save life of the victims for the Financial Year 2020-21 has been allocated to DGHS under (A) Major Head 2210 Medical Sector Sub Major Head 01 221001200830050 (Head of Account) at serial no: 60 Financial incentive to Good Samaritans for transporting Road Traffic Accident victims to hospital for medical care (Head of Account Name).

The implementation of the scheme of "Good Samaritan" by GNCTD has been approved as a regular scheme vide Cabinet Decision No. 2752 dated: 03-10-2019 on the modalities as approved vide Cabinet Decision No. 2456 dated: 06-01-2017.

The scheme is to be implemented by all health care service providers within the territorial jurisdiction of GNCTD; irrespective of their size and ownership (Private, Government, Autonomous bodies, Municipal bodies/Corporations etc.). The policy shall abide by all rules, regulations and conditions of the guidelines of the Hon'ble Supreme Court of India regarding protection of Good Samaritan Writ Petition (Civil) No. 235 of 2012 (Savelife Foundation & Anr. Vs Union of India & Anr.).

Good Samaritans/By Standers shall be rewarded with Rs. 2000/- (Rupees Two Thousand) only, per victim and an Appreciation Certificate from GNCTD for this generous act. In case of multiple Samaritan/By standers (i.e. more than one Samaritan/By stander); the amount shall remain same i.e. Rs. 2000/- (per victim); which may be distributed equally amongst them. However, the Appreciation Certificate will be issue individually in the name of each Samaritan


The Budget already allocated to DGHS is further allotted to all Delhi Government hospitals. In the case of private hospitals and the hospitals of the Central Govt., ESIC, Municipal Corporations, Autonomous Bodies, Railways, Army etc; funds are allocated to the concerned District CDMOs in respect of the Institutions falling with their operational areas/territorial jurisdiction. The fund allocation is enclosed as Annexure-I.

The modalities to facilitate the reward of incentive money and Certificate of Appreciation are enclosed as **Annexure-II**.

All the hospitals are further requested to publicize the scheme and the guidelines on protection of Good Samaritans through flex boards /banners for generating awareness among the masses.



Payment Modalities for disbursal of the reward money along with a Certificate of Appreciation to Good Samaritans/By Standers

1. Funds for the disbursal of the reward money along with a Certificate of Appreciation to Good Samaritans/By Standers will be parked in concerned end point delivery unit by DGHS as per the fund allocation schedule (Annexure-I).
2. Requisition for additional funds have to be made to DGHS.
3. The reward amount is Rs. 2000/- only, per victim along with a Certificate of Appreciation.
4. In case of multiple Samaritan/By standers (i.e. more than one Samaritan/By stander), the reward amount shall remain same i.e. Rs. 2000/- (per victim); which may be distributed equally amongst them. However, an appreciation letter will be issued individually in the name of each Samaritan.
5. The documentation of the particulars of the Good Samaritan in the Emergency unit must be done in a register. The particulars to be documented are name, age, sex, address, mobile/contact number, ID card details, MLC No, whether willing to accept cash reward.
6. If yes, Bank Account No. with IFSC Code. Recording of the mobile number of the Good Samaritan is a must, to obtain details related to Bank account and IFSC Code of the concerned person if these could not be produced during the time of transporting the RTA victim.
7. Registration of MLC is mandatory for the disbursal of the reward money.
8. Pre-signed Certificate of Appreciation must be made available at all times for immediate handing over to the Good Samaritan.

9. Once the processes enumerated at serial nos: 5, 6 & 7 are completed; the Certificate of Appreciation must be handed over to the Good Samaritan.
10. Line Listing of Good Samaritans is to be submitted to the Accounts Branch of concerned Hospital/CDMO Offices on Daily Basis for release of the financial incentive.
11. The concerned Accounts Branch will submit the bills **within two days** to the concerned PAO.
12. Concerned PAO to effect transfer of the incentive amount through electronic mode **within three days** of receipt of the bills raised by the hospitals/CDMOs.
13. **Payment is to be facilitated through electronic mode of fund transfer only. Payment must be released within (07) seven days of transporting the victim.**
14. Payment to Good Samaritans/By standers, who bring the RTA victims on their own, only would be made. **CATS Ambulances, Private Ambulances, PCR Vans will not be eligible under the scheme.**
15. The approved Certificate of Appreciation will be printed by CMO (Store and Purchase), DGHS. The certificate along with a covering envelope is to be indented from DGHS for issue at the point of release of the financial incentive.
16. The authorized signatories for the issue of the certificates are the **Casualty Medical Officer on Duty, further authenticated and countersigned by the CCMO of the concerned Hospital.**
17. The details of the Good Samaritans/ Bystanders in respect of the private hospitals and the Hospitals of the Central Govt., ESIC, Municipal Corporations, Autonomous Bodies, Railways, Army etc. will be authenticated and shared by the CCMO of concerned institutions through mail to their respective Chief District Medical Officers for processing the release of the financial incentive.
