ORDER

WHEREAS Mr. Manphool Singh, Nursing Officer, Dr. B.R.A.I.R.C.H., AIIMS New Delhi was charge sheeted vide Office Memorandum No. F.7-156/2007 -Estt.(Dr.BRA IRCH) dated 02-02-2021 under Rule 14 of the Central Civil Services (Classification Control and Appeal) Rules, 1965 with the following article of charge:-

Articles of charge-

Mr. Manphool Singh, while working as Nursing Officer, Dr. BRAIRCH, AIIMS, New Delhi absented himself from duty w.e.f. 29.01.2020 to till date unauthorisedly, willfully without prior intimation or sanction of leave by the competent authority and has failed to respond three recall notices dated 02.03.2020, 27.04.2020 & 01.07.2020 issued to him vide Memorandum No. F.7-156/2007-Estt(Dr. BRAIRCH).

By his act of unauthorized absence, Mr. Manphool Singh, Nursing Officer has exhibited gross misconduct acted in a manner unbecoming of an Institute employee; thereby contravening Rule 3(1), (ii) & (iii) of the CCS (Conduct) Rules, 1964 with Regulation 33 of AIIMS Regulation, 2019 as applicable to the employees of the Institute.

AND WHEREAS chargesheet was served to Mr. Manphool Singh, Nursing Officer, Dr. B.R.A.I.R.C.H., AIIMS New Delhi vide Office Memorandum No. F.9-156/2007-Estt.(Dr.BRA IRCH) dated 02-02-2021 with the direction to submit a written statement of defence. Instead of submission of his written statement in respect of Article of Charge, he tendered his resignation letter dated 18.03.2021. However, it was decided by the Competent Authority to continue with the disciplinary proceedings.

AND WHEREAS Disciplinary Authority had appointed Mr. Bhoop Singh, Administrative Officer as Inquiry officer under Sub-rule (2) read with Sub - Rule (22) of Rule 14 of the CCS (CCA) Rules, 1965 vide Order No. 7-156/2007-Estt (Dr. BRAIRCH) dated 30.05.2022.

AND WHEREAS the Inquiry Officer after holding the inquiry submitted the report therein the charges framed against Mr. Manphool Singh, Nursing Officer was found to be "Stand proved"

AND WHEREAS a copy of the inquiry report was forwarded to Mr. Manphool Singh, Nursing Officer at available addresses in his service records along with his email at singhmpps2006@gmail.com with a direction that he may make representation or submission on the report of the inquiry officer in writing to the Disciplinary Authority. But he failed to submit his reply within the stipulated time period of 15 days.


AND WHEREAS, after having gone through the report of the Inquiry Officer and considering the evidence on record and the facts circumstances of the case, the President (AIIMS) and Disciplinary Authority for good and sufficient reasons has come to the conclusion that imposition of penalty of "Dismissal from service which shall ordinarily be a disqualification for future employment under the Government" on Mr. Manphool Singh, Nursing Officer, Dr. B.R.A.I.R.C.H., AIIMS New Delhi would meet the ends of justice.

NOW, THEREFORE in exercise of the powers vested with the Disciplinary Authority under Rule 15 of the CCS (CCA) Rules 1965 read with Regulation 33(2) of AIIMS Regulation 2019, the penalty of **"Dismissal from service which shall ordinarily be a disqualification for future employment under the Government"** is hereby imposed on Mr. Manphool Singh, Nursing Officer, Dr. B.R.A.I.R.C.H., AIIMS New Delhi with immediate effect.
