Against GeM Bid Nos. GEM/2024/B/4470559 dated 11.01.2024, and GEM/2024/B/4467490 dated 11.01.2024, respectively for the procurement of OEM Cartridges in which M/s. Prateek Computer Peripherals have participated.

During the course of techno-commercial evaluation of the aforementioned GeM Bids, it has come to the attention that M/s. Prateek Computer Peripherals have submitted the fake and forged OEM authorization certificates as confirmed by the OEM.

Such actions not only violate the terms and conditions of the bidding process but also undermine the integrity of the procurement system.

Prateek Computer Peripherals have been blacklisted for participation in the bids issued by AIIMS, New Delhi in cognizance with the AIIMS Purchase Manual – 2018, Rule 151 of the General Financial Rules 2017, and guidelines on the debarment of firms from bidding issued vide O.M No. F.1/20/2018 – PPD dated: 02.11.2021 by the Procurement Policy Division, Department of

Expenditure, Ministry of Finance, Govt. of India, for the period of two (2) years w.e.f. 28.05.2024 due to the breach of code of integrity.
