Qualification & Experience

- (i) Bachelor degree in Law from a recognized university and registration with any Bar Council in Delhi.
- (ii) Professional experience of not less than 7 years in the Supreme Court/ High Court / Central Administrative Tribunal (CAT)/District Court/Other Courts.
- (iii) Good communication skills and good knowledge of law and procedure.

Desirable Qualification

Experience in dealing with the cases related to Government Hospitals/Medical Colleges/Medical Research.

Mode of Selection

- 1 The mode of selection on the basis of interaction by selection committee constituted by AIIMS, New Delhi.
- 2 In case large number of applications are received, short-listing of applications will be done. The department reserves the right to decide the criteria for short-listing of application.

- 3 Candidates so short-listed will be called for interaction. Intimation will be sent to the candidates by post to the respective at the correspondence address or by email on the email address, as given in the application form or over the telephone number given by the applicant.
- 4 Candidates will have to produce all original documents at the time of the interaction.
