- 4. The deputation tenure of defence service personnel will be as prescribed by Ministry of Defence from time to time
- 5. The Central or State Government officials as specified above for deputation shall only be considered for absorption
- 6. The officials on deputation will be eligible for 20% security allowance on the Basis pay along with other allowances as admissible to Central Government employees.
- 7. The departmental officials who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion
