1. The post carry usual allowance as admissible to Central Government Servant of similar status stationed at Delhi / New Delhi.
2. The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through ON-LINE mode. The On-line registration of applications is made available on AIIMS website [www.aiims.edu/www.aiimsexams.org](http://www.aiims.edu/www.aiimsexams.org) from 07.09.2018 to 06.10.2018 upto 5:00PM. No documents including the Registration Slip of on-line application from is required to be sent. However, all the applicants are advised to keep a copy of registration slip with them.
3. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling all the eligibility criteria as on the closing date of applications, failing which their application will be rejected.
4. The Online Registration will be closed by 05:00PM on 06.10.2018. The candidature of such applicants who fails to complete the online registration by the stipulated date and time will not be considered and no correspondence in this regard will be entertained.
5. The candidate must ensure that their photo, signature and thumb impression should be clearly visible in preview at the time of filling of application in online mode. If photo/signature/thumb image is displayed small or not visible in preview on website, that means photo/signature / thumb impression is not as per the AIIMS prescribed format and in that case, your application will be rejected.
6. Application Fees – Exempted for Person with Disabilities.
7. Age Relaxation:
  - i) Upper age limit shall be determined as on last date of receipt of applications.
  - ii) No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancy.
  - iii) Age relaxation permissible to various categories is as under:-

UR + PWD + Central Govt. Civilian employee (General / Unreserved who have rendered not less than 03 years regular and continuous service in the same line or allied cadres.	50 years
UR+PWD (OL)	45 Years
UR + PWD (OL) +AIIMS regular / Project employees with 03 years of regular and continuous service. (The term AIIMS employee does not include ad-hoc, Daily Wages, Temporary Status, Contractual Employees, Outsourced employees or Part Time Employees).	50 years

PWD + Ex-Servicemen and Commission Officers including ECOs /SSCO- for Group A & B posts:- 50 years

- (a) Fifteen year subject to the condition that on the closing date for receipt of applications the continuous service rendered in the Armed Forces by an Ex-servicemen is not less than six months after attestation. This relaxation is also available to ECOs /SSCOs who have completed their initial period of assignment of five years of Military Service and whose assignment has been extended beyond five years as on closing date and whose case the Ministry of Defence issues certificates that they will be released within 03 months on selection from the date of receipt of offer of appointment. Candidates claiming age relaxation under this para would be required to produce a certificate in the prescribed proforma to the Commission.

Note:- Ex-Servicemen who have already secured regular employment under the Central Govt. in a Civil Post are permitted the benefit of age relaxation as admissible for Ex-Servicemen for securing another employment in any higher post or service under the Central Government. However, such candidates will not be eligible for the benefit of reservation. If any for Ex-Servicemen in Central Govt. jobs.

- (b) In order to qualify for the concession under (a) above, candidates concerned would be required to produce a certificate that they have been released from the Defence Forces. The certificate for Ex-Servicemen and Commissioned Officers including ECOs /SSCOs should be signed by appropriate authorities specified below and should also specify the period of service in the Defence Forces:-

- (i) In case of Commissioned Officers including ECOs /SSCOs:  
Army: Directorate of Personnel Services, Army Headquarters, New Delhi.  
Navy: Directorate of Personnel Services Naval Headquarters, New Delhi.  
Air Force: Directorate of Personnel Services, Air Headquarters, New Delhi.
- (ii) In case of JCOs /Ors and equivalent of the Navy and Air Force;  
Army: By Various Regimental Record Offices.  
Navy: Naval Record, Bombay  
Air Force: Air Force Records, New Delhi.

8. Any dispute in this regard to any matter referred to herein shall be subject to the jurisdiction of Delhi Courts alone.
