- iv) In case of SC/ST/OBC candidate, a certificate to this effect from the Competent Authority of the district in the prescribed proforma. OBC candidates must submit the caste certificate which has been issued not earlier than six month of the date of issue of this letter as per central list of Government of India in the proforma provided by the DOP&T, Govt. of India vide O.M. No.36036/2/2013-Estt.(Res.) dated 30.05.2014.
- v) Candidates already in service have to bring along a 'No Objection Certificate' from his/her present employer. Relieving letter is required at the time of joining of the post.
- vi) Experience Certificate, if any.
- vii) In case any certificate is in regional language, its English/Hindi translation duly authenticated by the Competent Government Authority.
