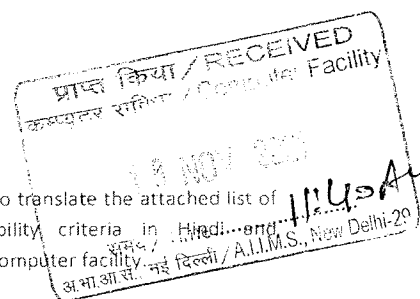

- VI. Certificate- Technical competence to handle sophisticated instruments like autoanalysors, spectrophotometers, flame photometer etc.

SC/ST/OBC is required to submission of Caste certificate on a prescribed format issued by the competent authority at the time of verification of documents. Community should be clearly mentioned in the certificate as per the Central Government list.
