TERMS & CONDITIONS:

- 2. The firm must be registered and having TIN No./ Registration No. (Please mention TIN/Registration No. on the bids) or else the quotation will be REJECTED.
- 3. The bidder is required to submit the bid in two parts viz:
 - (a) Technical Bid in one envelope containing of the following information:
 - i. Technical descriptions of the quoted model (s)
 - i. List of all consumables/accessories required for running the equipment
 - iii. Terms & conditions including Warranty/CAMC/Taxes etc.
 - iv. Original catalogues of the quoted model (s)
 - v. Earnest Money Deposit (EMD)
 - vi. All required affidavit/undertaking (s)
 - vii. Principal company authorization letter.

- 11. Post Warranty CAMC: The bidders must submit their quote (rates) for CAMC for the next subsequent three years from 3rd to 5th year (including all spares and labor) in their price bid. Failure to comply this condition will entail the rejection of the bids. The cost of the CAMC will be added for ranking/evaluation purpose.
