- The firm must be registered and having TIN No./ Registration No. (Please mention TIN/Registration No. on the bids) or else the quotation will be REJECTED.
- 3. The bidder is required to submit the bid in two parts viz:
 - Technical Bid in one envelope containing of the following information:
 - Technical descriptions of the quoted model (s)
 - ii. List of all consumables/accessories required for running the equipment
 - iii. Terms & conditions including Warranty/CAMC/Taxes etc.
