# GENERAL TERMS & CONDITIONS

## Eligibility Criteria

### 1. Documents Comprising the Limited Tender

1.1 The **Two Bid System**, i.e. “Techno – Commercial Bid” and “Price Bid (Financial bid)” prepared by the bidder shall comprise the following:

#### A) **Techno – Commercial Bid (Un priced Tender)**

- i) The tenderer/supplier is a Distributor/ Manufacturer
- ii) The bidder have to fill **Annexure-I** format.
- iii) The bidder have to fill tender acceptance Form **Annexure-II**
- iv) The bidder have to submit a copy of GST Registration Certificate
- v) The bidder shall furnish an undertaking as per **Annexure-VI** that the firm has not been non-blacklisting by any government/Private institution.
- vi) The tenderer/supplier shall furnish an undertaking as per **Annexure-VI** that there is no vigilance/CBI case pending against the firm/supplier.
- vii) The tenderer/supplier has to give an undertaking as per **Annexure-VII** for fall clause i.e the firm is not supplying the same item at the lower rate quoted in the limited tender to any Govt. Organization or any other Institute (Fall Clause)
- viii) List of Organisation where firm are supplying goods.
- ix) The tenderer/supplier have to submit Original Sample alongwith quotation as per **Annexure-VIII**
- x) the tenderer/supplier have to submit in house test report of submitted sample batch Report.

#### B) **Price Bid (Financial Bid):**

This should be filled as per showed in **Annexure III**.

#### ***N.B.***

1. All pages of the Tender should be page numbered
2. It is the responsibility of bidder to go through the LTE document to ensure furnishing all required documents in addition to above, if any.
- 1.2 The authorized signatory of the bidder must sign the tender duly stamped at appropriate places and initial all the remaining pages of the tender.
- 1.3 A bidder, who does not fulfil any of the above requirements and/or gives evasive information/reply against any such requirement, shall be liable to be ignored and rejected.
- 1.4 Tender sent by fax/telex/cable/electronically shall be ignored and not accepted at all.
2. **Limited Tender currencies**
- 2.1 The bidder supplying indigenous goods or imported goods shall quote only in Indian Rupees.
- 2.2 Tenders, where prices are quoted in any other way shall be treated as non-responsive and rejected.
3. **The Schedule of Requirement should be comply by the firm as per **Annexure-IV****
4. **The item should be quoted as per specification at **Annexure-V****

**5. Submission of Tenders**

The bidders are to drop the tenders in the tender box of office of Stores Officer (CNC), Stores Section, Room No. 3, 1st Floor, New Pvt. Ward at AIIMS New Delhi-110 029 or the same shall be submitted by the tenderer by hand to concerned dealing hand or nominee of Stores Officer (CNC) on above mentioned address. The officer receiving the tender will give the tenderer an official receipt duly signed with date and time. The bidders must ensure that they deposit their tenders not later than the closing time and date specified for submission of tenders.

**6. Opening of Tenders**

The purchaser will open the tenders at the specified date, time and place as indicated in the LTE. Authorized representatives of the bidders, who have submitted tenders on time may attend the tender opening provided they bring with them letters of authority from the corresponding bidders.

**7. Eligible Bidders**

This Limited Tender Enquiry is open to all suppliers who fulfil the eligibility criteria specified in these documents.

**8. GST**

If a bidder asks for GST to be paid extra, the same must be specifically stated. In the absence of any such stipulation, the price will be taken inclusive of GST and no claim for the same will be entertained later.

**9. Tender Validity**

The tenders valid for acceptance for a period of 90 days from the date of tender opening prescribed in the LTE document. Any tender valid for a shorter period shall be treated as unresponsive and rejected.

**10. Late bid**

A tender, which is received after the specified date and time for receipt of tenders will be treated as "late" tender and will be ignored.

**11. Withdrawal of Tender**

No tender should be withdrawn after the deadline for submission of tender and before expiry of the tender validity period. If a bidder withdraws the tender during this period, it will result to take action against the bidder as deemed fit for debarring etc.

**12. Qualification Criteria**

Tenders of the bidders, who do not meet the required Qualification Criteria will be treated as non - responsive and will not be considered further.

### 13. Evaluation of Bid

The evaluation of bid will be done as per document required as per “eligibility criteria” in General Terms & Condition of LTE and quality of sample.

### 14. Purchaser’s Right to accept any tender and to reject any or all tenders

The purchaser reserves the right to accept in part or any full any tender or reject any or more tender(s) without assigning any reason or to cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidders.

### 15. Payment Terms

Payment shall be made through electronic transfer in NEFT/RTGS subject to recoveries, if any, by way of liquidated damages or any other charges. as per terms & conditions of contract in the following manner.

Payment shall be made in Indian Rupees as specified in the contract in the following manner: **On delivery:**100% (Hundred) % payment of the contract price shall be paid after receipt of goods in good condition and upon the submission of the following documents:

- (i) Three copies of supplier’s invoice showing contract number, goods description, quantity, unit price and total amount;
- (ii) Two copies of packing list identifying contents of each package;
- (iii) Inspection Note issued of Company.

The supplier shall not claim any interest on payments under the contract.
