1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.
2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.

4. Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 7 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
5. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
6. Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
7. Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 2 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
8. Malicious Code Certificate:

The seller should upload following certificate in the bid:-
(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-
(i) Inhibit the desired and designed function of the equipment.
(ii) Cause physical damage to the user or equipment during the exploitation.

(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.
9. **Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address e-mail Id and Phone No. required to be furnished along with the bid
10. **OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contract

rates. The delivery period of quantity shall commence from the last date of original delivery order and in case where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

14. The Buyer has an existing set up / inventory of similar products. The offered / supplied product must be compatible with existing system. The bidder has to ensure Compatibility of the supplied items or shall have to include in the supply the necessary hardware / software to make them compatible at no extra cost to the buyer. 24. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacture of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quote price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 15% of total value.
25. Purchase Preference linked with Local Content (PP-LC) Policy:

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amended to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. 28. ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.
29. Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.
30. The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
31. To be eligible for award of contract, Bidder / OEM must possess following Certificates / Test Reports on the date of bid opening (to be uploaded with bid):

32. Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
33. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 34. Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.
35. Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
36. Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
37. Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide Comprehensive Maintenance Service for next 5 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into a CMC agreement with the Successful Bidder / OEM after expiry of the Warranty period at above mentioned rate and the payment for the CMC charges would be made Biannually after rendering of the CMC Services of the relevant CMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the CMC contract when called upon by the buyer. CMC would include cost of
5% of cost of quoted equipment
(Upload the undertaking). The original Performance Security of contract will be returned only after submission and verification of AMC Performance Security for 8% of total CMC value valid up to CMC period plus 2 months (if there is no other claim).
38. Warranty period of the supplied products shall be 2 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
39. Over and above the normal Warranty terms as per GeM GTC, the successful bidder / OEM shall have to provide Comprehensive Warranty during the entire Standard warranty period as per contract. : The comprehensive

warranty shall be covering the following scope

Including all spares, all accessories, batteries, all 3rd party items and labor

40. Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.
41. Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

TECHNICAL SPECIFICATIONS:

LOW TEMPERATURE HYDROGEN PEROXIDE GAS PLASMA STERILIZER	
1.	The Sterilizer should use Low Temperature H ₂ O ₂ Gas Plasma for sterilization with plasma energy generated using DBD/LFPS/RF to kill the microorganisms on Instruments placed in Sterilization Chamber and should come with 15-30 minutes Biological Indicator reader. Plasma to be generated inside/outside sterilization chamber.

2.	Sterilizer should have chamber temperature of less than 60° C at all the time during the cycle.
3.	Sterilizer should have Total volume 130-180 liters with usable volume 76-120 Liters Minimum two removable Shelf with shelf size should be able to accommodate 2 Trays to sterilize Telescopes easily, Camera Head, Fiber Optic Cable easily. Each shelf should have the capacity of minimum 20-25Kgs.
4.	Sterilizer should have preprogrammed cycles without any room for human error due to manual programming the longest cycle should not exceed 65+-10 minutes. There should be separate cycle for non- lumen/lumened/flexible endoscope.
5.	The quoted model should be certified by USFDA or European CE with 4 digit notified body number or BIS Indian standard or ISO 13485 from notified body. CDSCO certificate is a must. Equipment should be IEC 60601-1-1 & IEC 60601-1-2 certified. All certificates should be enclosed with tender document failing which bidder will be rejected.
6.	The quoted model should be endorsed/certified by European CE for implementing a quality assurance system for design, manufacture and final inspection of the sterilizer/ BIS standard/ISO 13485 from Notified Body.
7.	The leading/reputed device manufacturers (like Karl Storz, Stryker, Richard Wolf, Smith & Nephew, Intuitive Surgical etc.) should clearly specify in their instruments IFU (Instructions for Use) the sterilizer brand as a validated method for reprocessing/sterilizing their instruments (like scopes, cameras, light cords etc.) Validation Documents from at-least two of these companies mentioned above needs to be submitted.
8.	The By-products of the sterilizer should be non-toxic and eco-friendly.
9.	Biological Indicator Result should come in 15-30 minutes and both BI Reader and Indicator should be from same OEM to assure proper validations.

10.	Sterilant (H ₂ O ₂ concentration) should be in cassette/Cartridge or bottle multidose for accurate and calibrated dispensing and avoid wastage with no left over in the machine for use safety. Equal volume of the sterilant should be used for easy tracking of consumption by user. Sterilant should be stored at room temperature for entire shelf life and should have a shelf life of minimum 01 year. The Sterilant should have leak proof indicator.
11.	Original Manufacturer or their subsidiary or authorized dealer who is quoting should be present in India having Plasma Sterilizer selling experience of more than 5 years and having minimum 15 installations.
12.	The Plasma Sterilizer should confirm to the following norms and Directives: ISO 9001, ISO 13485, ISO 14937.
13.	The Sterilizer should be supplied with Online UPS with the backup of 01 hour and Heat-Sealing Machine.
14.	Rates of Consumables will be frozen for period of 10 years to be quoted along in BOQ document.
15.	The operation of Sterilizer should have no requirement of additional Water Supply.

Accessories & Consumable:

The price list of all spares parts, accessories, consumable items (required to use on machine) should be quoted separately in the financial bid section (PDF) and the quoted rates will be valid till the warranty & CAMC period (i.e.10 years) from the date of installation of equipment. If, the price of any spares, consumables/accessories/ parts not quoted by the firm in the price bid and will required in future to run the system, the same has to be supplied by the firm at free of cost without any further term & conditions.
