

**Concept/Description**


The *FloTrac* sensor is a sterile, single use kit that monitors pressures when attached to pressure monitoring catheters. The disposable sterile cable with a red connector interfaces exclusively with an Edwards cable that is specifically wired for the pressure monitor being used. The disposable sterile cable with a green connector interfaces exclusively with the Edwards APCO cables for use with the Edwards arterial pressure based cardiac output monitoring devices or hardware.

The *FloTrac* sensor has a straight, flow-through design across the pressure sensors with an integral flush device.

**Indications**

The *FloTrac* sensor is indicated for use in Intravascular pressure monitoring. It is also indicated for use with the Edwards arterial pressure based cardiac output monitoring devices or hardware to measure cardiac output.
