<b><u>Actiwatch</u></b>	
Should be light weight (less than 35gms including battery), compact and convenient to wear continuously for several days.	
Should have six internal channels like Body position, Activity Sensors (xyz Axis), ambient light and patient marker.	
Should have one external signal input Upgradable for any one channel like Respiratory analysis, Sleep Stage Recording or Blood Pressure Recording.	
Should have sampling rate up to 256/sec.	
The device should have the ability to work on rechargeable battery, which should have sufficiently long time to record the uninterrupted activity for minimum 14 consecutive days.	
<b><u>Actigraphy analysis Software</u></b>	
Should have capability to export and import the complete study in EDF Format, exe format, and reports can be exported to Excel and PDF format.	
The unit should be provided with minimum two License CDS.	
Should have capability/upgradability of putting 6 channels EEG OR to see the differentiation of wake, REM and Non-Rem stages.	
Should have capability of recording day time activity pattern.	
Should have capability of Automatic artifact detection.	
Should have capability of monitoring luminous flux and irradiance.	
Should have provision for interface with PC for data download post processing and print out of the complete Report.	
The unit should be CE and FDA approved.	




