GENERAL TERMS OF SALE TO HBDC END-USERS

- I – GENERAL REMARKS:** All purchase orders imply that the customer accepts the present general terms of sale and renounces their own purchasing conditions. When authorizations or formalities are required, especially concerning imports and exchange controls, for importing into the destination country or for the payment of the products sold, obtaining these authorizations or accomplishing these formalities in a timely manner is the entire responsibility of the customer. - II – DELIVERY, INSTALLATION, AND USE:** Delivery conditions (Incoterms) are mentioned on the order confirmation, delivery note and invoice. By default, Cepheid products are sold "ex works / Maurens-Scopont", or other Cepheid facility. The customer is responsible for all transport and handling fees, assembly and insurance costs, customs duty and taxes, from the moment the goods leave the Cepheid facility. The customer must, in the event of losses, spoilage delays, take all the necessary steps and accomplish all the necessary formalities with the haulage contractor and inform Cepheid HBDC. Delivery dates are only given as an indication; delays do not give the buyer the right to cancel the purchase orders in progress; refuse the products or claim compensation. Reservations expressed on receipt of the products should be communicated to Cepheid HBDC within a few hours of delivery.
- III – PRICES – PAYMENT:** Cepheid products are invoiced at the prices and rates in force as at the date the goods leave the store. Prices are determined "ex store". Special packaging is invoiced in addition.
Payment conditions are payment in U.S. Dollars received in advance of shipment date.

- VI – GUARANTEE – RESPONSIBILITY:** Our reagents are guaranteed until the date of expiry date unless otherwise stipulated on the product or in the documentation. Cepheid warrants that each HBDC GeneXpert Instrument or Infinity instrument purchased from Cepheid or its authorized distributor under this HBDC Warranty (the covered "instrument") (i) will be free from defects in material and workmanship for a period of two years after shipment for GeneXpert instruments and for a period of one year after shipment for Infinity instruments, (ii) conform to Cepheid's published specifications for the instrument, and (iii) are free of liens and encumbrances when shipped to Purchaser. 


