Specification for Autodecalcifier System (01No)

- 1. Decalcifying system to decalcify the large and small bones faster to reduce 60-70% or more of decalcifying time.
- 2. It should integrated temperature controller to set the process time from 30 min. to 100 hrs or more.
- 3. It should have holders of different sizes for at least 4 holders for 800ml, 8 holders for 150ml and 40 holders for 20ml sample containers.
- 4. It should have highest level of safety for maximum tissue preservation without damaging the tissue due to excessive heat generation or chemical reaction during the process of decalcification.
