Specifications for Antibodies:

1. The antibodies should be specific and there should be no cross reactivity with other proteins.
2. They should have long shelf life.
3. The antibody should be storable at 2-8° C.
4. Antibodies should be such that they can be used on formalin fixed paraffin-embedded tissue section and/or frozen cryostat sections.
5. They should be usable in very high dilution with or without antigen retrieval. If antigen retrieval is required it should preferably be using citrate buffer and microwave.
6. They should be compatible with the detection system of streptavidin biotin Horseradish immunoperoxidase / polymer detection kit.
7. No antigen retrieval using proteolysis enzymes should be required.
