Technical specifications for Flexible Fibreless Portable Bronchoscopy Visualization System

1. Easy to transport & Set up flexible video scope with monitor for Inspection, Intubation and Bronchoscopy.
2. It should be supplied with touch screen monitor of minimum eight-inch screen size having facility with video output.
3. Monitor should have video recording and capability to take still images and should have storage of minimum 8 GB.
4. Monitor should have at least 4 hours battery backup, it can be easily mounted on IV pole and maximum start up time should not be more than 10 sec.
5. Length should be at least 600mm.
6. It should be direct both the way at least 130 degree with thumb control lever with pediatric scope, at least 150 degree up and at least 130 degree down with Adult scope and at least 140 degree up and at least 110 degree down with large adult scope.
7. It should have ET Tube parking slot.
8. Scope should have outer dimension:
 - i. Outer diameter: 4.8 - 5.2mm, working channel more than 2.0mm
 - ii. outer diameter of 5.6 - 5.9mm, working channel of minimum 2.8mm
 - iii. Monitor
 - iv. price for the above should be provided along with bid.
9. It should have additional working channel and can be used for oxygen flushing.
10. It should be integrated with camera chip and LED light source.
11. Should be USFDA 510K approved.
12. it should have endotracheal tube parking slot.

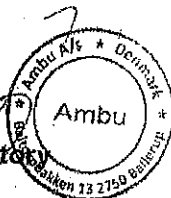
