- 1. Should be able to deliver fluids using two bags at wide range of flow rates upto atleast 30 litres/hour.
- 2. The temperature of fluid exiting from the infuser should be within one degree Celsius of set temperature even at high flow rate
- 3. Should have an aluminium heat exchanger for faster heating that uses counter-current recirculating solution that provides effective and stable heating.
- 4. Should have integrated air detector in the hardware that automatically clamps the patient line when air is detected. The air detector and clamp should automatically unclamp and resume operation once the air is removed from gas vent. All this should be done without disconnecting from the patient.
- 5. Should have integrated automated pressure chambers that accommodate standard blood and crystalloid bags and pressurize to a constant pressure of 300 mm Hg.
